Ltd. (JV GenLot), thereby (i) confirming the disqualification by the Special Bids and Awards Committee of JV GenLot, and (ii) leaving the bid of the Joint Venture of POSC, PGMC. and ILTS as the Single Calculated and Responsive Bid with respect to the PCSO's public bidding for its new lottery system.
