

PRIMARY PURPOSE


To engage in, conduct, and carry on the business of buying, selling, distributing, marketing at wholesale and retail insofar as may be permitted by law, all kinds of goods, commodities, wares and merchandise of every kind and description;
to enter into all kinds of contracts for the export, import, purchase, acquisition, sale at wholesale or retail and other disposition
for its own account as principal or in representative capacity


