#### Clarification of News Report

We respond to the Exchange's request for comment on the article entitled "Duterte lifts ban on lotto" posted in The Manila Times (Online Edition) on July 31, 2019 which provides ,in part:

"President Rodrigo Duterte has lifted the suspension of lotto operations, Malacañang said on Tuesday night.

'As per the advice of Executive Secretary Salvador C. Medialdea, the suspension of Lotto operations has been ordered lifted by the President,' Palace spokesman Salvador Panelo said in a statement.

But all other games operated by the Philippine Charity Sweepstakes Office (PCSO), as well as the franchises, licenses or permits granted by the charity agency for small-town lottery, keno and Peryahan ng Bayan shall remain suspended 'pending the investigation of illegal activities and corrupt practices related thereto until the Office of the President evaluates the results of said probe,' Panelo said.

'Franchise holders and operators of lotto outlets may now resume with their operations. The lifting of the suspension of lotto operations takes effect immediately,' he added."

Please be advised that Pacific Online just received this morning an advice from the Philippine Charity Sweepstakes Office (PCSO) confirming the resumption of its lotto gaming operations today. We were likewise advised that PCSO General Manager Royina Gama will be making further announcements on the matter within the day.

With respect to our Equipment Lease Agreement (ELA) with PCSO the latest extended term of which is due to expire today, please be advised that we have had an agreement in principle on the terms of a further renewal thereof pending the completion of PCSO's process to procure, by public bidding, a new online lottery system. Until a formal agreement has been entered into, however, we will be unable to make further announcements thereon.

#### Other Relevant Information

Pacific Online will be updating the Exchange as soon as relevant and concrete information on our ELA becomes available. Understandably, the PCSO Management are currently preoccupied with the resumption of their lottery operations this morning.
